

Partry Central Air Jumper Rules:

GENERAL RULES FOR A SAFE OPERATION.....

- A) NO FLIPS.
- B) NO ROUGH PLAY OR CLIMBING ON THE NET WALLS. STAKE DOWN ALL 4 SIDES!
- C) NO SHOES IN THE INFLATABLE UNIT.
- D) NO SHARP OBJECTS IN OR AROUND THE INFLATABLE UNIT.
- E) NO FOOD, DRINKS, OR GUM IN OR AROUND THE INFLATABLE UNIT.
- F) UNIT MUST BE SUPERVISED AT ALL TIMES.
- G) KIDS OF THE SAME AGE MUST JUMP IN THE INFLATABLE AT THE SAME TIME.
- H) DO NOT EXCEED THE RECOMMENDED CAPACITY.
- I) NO EYEGLASSES OR JEWELRY IN THE INFLATABLE.
- J) NO SILLY STRING IN OR AROUND INFLATABLE UNIT. IF FOUND AT TIME OF PICKUP THERE WILL BE A \$40.00 CLEANING CHARGE PAYBLE IN CASH AT TIME OF PICKUP.
- K) IN EXCESSIVE WINDS IN EXCESS OF 25 M.P.H., UNLOAD UNIT UNTIL WEATHER CALMS.

SET UP: Units must be operated over a smooth, compatible surface such as grass or hard to surface. The unit may NOT be operated on rough surfaces such as rocks, bricks, glass or any jagged objects. The unit POSITIVELY may NOT be located next to any wall, pole or fixed object, a minimum of 2 ft. clearance on all sides must be observed at all times. Equipment must be anchored in ground prior to use.

OPERATION: Adult supervision is required at all times. Observe rules posted on unit. Compatible age groups must play on equipment at same time. Age groups must not be mixed. The max. number of kids of each age group that should jump at one time is:

Lessor is not responsible for any injuries occurring to Lessee or to any persons using the leased property. Lessee further agrees to hold Lessor free and harmless against any claims; and further, Lessor shall be indemnified for any and all costs incurred due to claims for anyone; including court cost and attorneys fees, and other related costs involving the use of the leased equipment. Lessee shall provide own liability insurance unless otherwise specified. Lessee is responsible for the replacement value of the new leased object in the event of theft, vandalism, fire or any act which may damage or destroy the leased property. Failure to make available equipment delivered to lessee for Lessor to pick up, shall make lessee liable to Lessor for an additional "one day rental fee" per day until all equipment is returned, or satisfactory arrangement is made with Lessor. If Lessee does not abide by the conditions of this agreement, then lessee must reimburse Lessor all court, and/or attorney fees incurred by Lessor to enforce this contract.

RAIN POLICY: Customer (Lessee) may cancel rental at any time prior to receiving equipment at their option due to inclement weather. If customer receives leased equipment, Lessors obligation to furnish equipment has been met and no rain checks or refunds will be issued. POLICY FOR WET WEEKEND FORECAST, I.E., POSSIBLE RAINY DAYS; THE CUSTOMER PAYS FOR THE UNIT ONCE THEY ACCEPT. UNDER NO CIRCUMSTANCES ARE REFUNDS GIVEN TO CUSTOMER DUE TO RAIN.
